

SCHEDULE RL-4
OUTDOOR LIGHTING ENERGY

I. AVAILABILITY

Service is available to any developer, community association, or governmental authority where 120-volt service exists. The cost of service provides for electricity only from existing Northeastern REMC (Northeastern) facilities. Any investment occasioned by the extension of secondary lines or the installation of a transformer for the sole purpose of this service shall require a contract setting forth the charge for the additional investment.

II. CHARACTER OF SERVICE

Electricity shall be provided for a dusk-to-dawn street and area lighting system using photoelectric control equipment and light fixtures. Installation shall be in accordance with Northeastern’s “Street Lighting Service Specifications.” Installation, ownership, and maintenance of the lighting system shall rest with the member requesting service under this rate. The developer, community association or governmental authority requesting this service shall sign a contract specifying the number of lights and size.

III. MONTHLY CHARGES

The Monthly Charge for each lamp, based on 4000 hours use per year shall be as follows:
