

SCHEDULE RL
RENTAL LIGHTING

I. AVAILABILITY

This schedule is available to any member of Northeastern REMC (Northeastern) for continuous year-round service for unmetered outdoor lighting where 120-volt service exists.

II. CHARACTER OF SERVICE

Dusk-to-dawn lighting service will be furnished, using photoelectric controlled equipment, mast arm, fixture, and lamp installed on an existing pole. Maintenance of the complete assembly and the cost of its electrical operation are included in this service. Except as provided for herein, any additional investment required for the sole purpose of providing this service shall require a contribution by the member equal to the actual investment cost.

III. MONTHLY CHARGES

The Monthly Charge for each fixture, including lamp and mast arm, controlled by a photoelectric relay, where Northeastern supplies service from an existing pole and secondary facilities shall be as follows:

When Northeastern must install new facilities before it can provide the requested service, the member will pay, in advance, the installation costs of such new facilities. These installation costs include the extension of overhead facilities from the nearest or most suitable pole to the point designated by the member for the installation of said lamp. However, instead of prepaying these installation costs, the member may elect to pay the following additional monthly charges:

For Each 30 Foot Pole	\$5.20

For Each Overhead Wire Span of 150 Feet or Less <small>(Exceeding 15 Feet)</small>	\$2.40
For The First Underground Wire Lateral of 50 Feet or Less <small>(Price includes pole riser and connections.)</small>	\$4.00
For Each Additional Underground Wire Lateral of 50 Feet or Less	\$2.50
For Each 8 Foot Mast Arm	\$1.20

A member may also request facilities such as special poles for fixtures or special protection for poles that are not provided for herein. The member will be required to contribute an amount equal to the cost of such special facilities. The member shall also be responsible for any costs required to repair, replace or push under sidewalks, pavement or other obstacles.

IV. MONTHLY CHARGES - DISCONTINUED SERVICES

The following rates are for luminaires that are not available for new installations:

VIII. CONTRACTS

Contracts under this tariff will be for not less than 1 year for service on existing facilities and not less than 5 years when Northeastern must install new poles. In the case of members contracting for 4 or more lamps, Northeastern reserves the right to include in the contract such other provisions as it may deem necessary to insure payment of bills throughout the term of the contract.

IX. HOURS OF LIGHTING

All lamps shall burn from one-half hour after sunset until one-half hour before sunrise, every night, or approximately 4,000 hours per annum.

X. OWNERSHIP OF FACILITIES

Northeastern shall own and maintain all facilities necessary for service including but not limited to fixtures, controls, poles, transformers, secondary conductor, and lamps. Northeastern will perform all service and necessary maintenance during its regularly scheduled working hours. Northeastern will normally replace failed lamps within 48 hours after notification by the member.

XI. TERMINATION OF SERVICE

The member may request termination of service at his option. Northeastern will remove its property upon such notice with reasonable diligence. Northeastern may remove its fixture and, in effect, cancel rental lighting service when:

1. Bills are unpaid (with proper notice from Northeastern), or
2. Such action is necessary to protect Northeastern from fraud, abuse, or vandalism.

Northeastern will not refund any part of any contribution(s) made by the member following the terms of this schedule.
